advised was depressed due to the fact she had lost her job and her husband was deployed in the military. advised she immediately contacted law enforcement after she received several text messages from indicating she had a gun in her mouth and would blow her head off.
Upon arrival, deputies made contact with who originally denied making any suicidal remarks. After further investigation, it was determined indeed transmitted several text messages which were suicidal in nature and involved the use of a firearm. advised Deputy Vanzo she was upset due to the fact she had lost her job and was about to experience a possible divorce from her husband. further advised if law enforcement wasn't called she had no intentions of carrying out the threats.
It should be noted, deputies confirmed these messages after reviewing the conversation between
In part, the messages sent from advised the following:-"Thanks for the call I wanted to blow my head. And no husband no were. Thanks hunn good night. I even had the gun until mom talked me down. Not my husband." -"I almost shot myself and this is what you write!!!!""Your wife almost shot herself. Sorry but it did not happen."
It should also be noted, deputies did not observe any firearm while on scene with
After further questioning, admitted she owned a firearm (unknown make and model); however, it was locked in a safe and the whereabouts to the key were unknown. also advised she did not have any ammunition for the weapon. Based upon the statements made coupled with the threat of using a firearm, Deputy Vanzo generated a Risk Protection Order for review.
Deputy Vanzo determined was unable to determine for herself if an examination was required. Based on the totality of the circumstances, Deputy Vanzo took into protective custody under the Baker Act, due to the substantial likelihood that without care or treatment, she will cause serious bodily harm to herself. was subsequently transported to Stewart Marchman act without incident.
