On 11/10/2019, Deputy Mitchell responded to ██████████, Port Orange, in reference to a miscellaneous call. ██████████ (R1), contacted VSO advising, ██████████ (O1), asked him to turn over her firearms due to on going mental illness. Upon Deputy Mitchell's arrival, contact was made with ██████████ who advised the following: ██████████ has been dealing with financial issues and having a hard time finding employment. ██████████ advised she is close to loosing her residence at ██████████ due to not being able to afford the payments. ██████████ advised she asked ██████████ to respond to store / keep her firearms away from her. She advised due to the financial crisis she is stressed out, on edge, suffering from anxiety, and has not been able to sleep. ██████████ stated she wanted to be "proactive" with her safety and the safety of others, by removing her firearms from her possession. She advised throughout the night she hears noises outside and goes outside to check while carrying her firearm, thus has not had a full night sleep in a long time. ██████████ advised she is depressed from the financial crisis and does not know what could happen if the firearms remain in her possession. ██████████ advised on paper and due to life insurance she is worth more to her family if she was dead. ██████████ denied wanting to hurt herself and denied wanting to hurt anyone else; advising she wanted to be "proactive" and remove the firearms from her possession. ██████████ turned over a Remington 12GA shotgun and Taurus .38cal revolver. ██████████ advised she does not have a Florida Conceal Weapon permit. Deputy Mitchell contacted ██████████ who confirmed he was contacted by ██████████ and requested to take possession of her firearms. ██████████ advised of her financial crisis and that she wanted to be proactive in her safety; but did not make any statements to harm herself or others. ██████████ completed a written statement affidavit. Deputy Mitchell completed a Risk Protection Order Firearms and Ammunition receipt which ██████████ signed and received a copy of. ██████████ was advised a Risk Protect Order would be completed and she advised she understood. Based on Deputy Mitchell's investigation ██████████ did not meet the criteria for a Baker Act.
