A criminal history was pulled on [REDACTED] and showed no prior felony convictions.

\*\*\* BWC ACTIVE \*\*\* On the above date and time, Deputy Estrada responded to [REDACTED] Deland, in reference to a suicidal person. Prior to arrival, dispatch informed responding units that the subject, [REDACTED] (V1), he had access to a firearm along with wanting to end his life. Deputies requested phone contact be made with [REDACTED] via dispatch, which was accomplished. Upon arrival, [REDACTED] stepped outside and deputies made contact with him. After speaking with [REDACTED] he stated "why should I live the next decade", followed by saying he wanted law enforcement to shoot him. Subsequently, [REDACTED] was placed into protective custody under the baker act. Deputy Estrada believed there is a substantial likelihood that without care or proper treatment [REDACTED] will cause serious bodily harm to himself or in the near future, as evidenced by recent behavior [REDACTED] was asked if he had any firearms, which he stated no. Deputies on-scene notated that no firearms were visible within the residence. Contact was made with the reporting party, [REDACTED] (R1), who is the sister of [REDACTED]. According to [REDACTED] spoke to her via cell-phone and stated he had a gun and wanted to blow his brains out. Immediately, [REDACTED] contacted the Volusia Sheriff's office. [REDACTED] was unable to provide a written statement due to being out of state. [REDACTED] advised that she did not know if [REDACTED] had access to firearms. At the request of [REDACTED] his neighbor [REDACTED] (O1) was provided the keys to the residence. [REDACTED] will be the care taker of the residence until [REDACTED] returns. [REDACTED] advised that he believed that [REDACTED] did not have access to firearms. Due to the circumstances, an R.P.O will be completed. [REDACTED] was transported to ACT for further psychological evaluation. Case Status: Closed
