stated as she, and were leaving the Doctor's office to take to Deland, she heard him make several comments about "shooting the next person to walk through the door". advised continued on by stating he wished to walk to his residence, so he could walk into traffic. advised stated he was "going to take a dirt nap" when he got home. stated continued making the suicidal comments, and ranted on about shooting others and himself for several minutes.
further advised behavior has become worse over the past several days. stated has made several comments about shooting other's and himself, and tried to get to his firearm prior to them stopping him. stated a few days prior, advised he was going to call his brother, and shoot him as he was coming through the door. advised she and took to the Doctor today, due to his statements and behavior, to suggest a possible change in medication. stated the Doctor wrote them an immediate referral to Deland Hospital for to be evaluated for confucion and depression. advised owns several firearms within his residence. completed a written statement.
Deputies made contact with who corroborated statements. went on to advise that when deputies arrived on scene, briefly speaking with advised her he was going to shoot the deputy. advised she then threw her hands up, to get deputies attention. advised she does not believe is in the right state of mind, due to making several suicidal statements throughout the past few days. advised has threatened to "Blow his brains out" on numerous occasions. completed a written statement.
