1. {Name of Respondent} [REDACTED] poses a significant danger of causing personal injury to himself/herself or others by having a firearm or any ammunition in his/her custody or control or by purchasing, possessing or receiving a firearm or any ammunition. The following specific statements, actions, or facts give rise to a reasonable fear of significant dangerous acts by the respondent:

On 07/30/2020 at approximately 0753 hours Deputy Brown responded to [REDACTED] Ormond Beach in reference to a verbal disturbance. Upon arrival contact was made with [REDACTED] (R1), who advised she and her boyfriend, [REDACTED] (V1), were arguing about ending their relationship. [REDACTED] advised [REDACTED] was not taking

the break-up well and on 07/29/2020, ██████████ advised her the following:

██████████ advised ██████████ that he was going to go to his father's residence. ██████████ advised his father does not wake up until approximately 1300 hours and he would wake up to find ██████████ with a shotgun in his mouth deceased. ██████████ advised it was going to be payback for his father treating him poorly while growing up. ██████████ also advised he was going to hang himself. ██████████ advised ██████████ frequently hallucinates and pictures her cheating on him with other people even when they are together. ██████████ advised ██████████ is supposed to take medications for bi-polar disorder but has not been taking it. ██████████ advised she is very scared of what ██████████ will do to himself when she officially ends their relationship. ██████████ completed a written statement of the events.

Deputy Brown made contact with ██████████ who advised he is fine and does not feel like harming himself. ██████████ advised ██████████ made everything up and denied everything she said.

Deputy Brown observed ██████████ to be visibly upset and crying during the encounter.

██████████ and ██████████ both advised ██████████ does not have access to firearms at their residence but his dad does own firearms.

A Risk Protection Order was completed and emailed to the appropriate people.

Based on Deputy Brown's investigation, without the proper care or treatment there is a substantial likelihood ██████████ will cause serious bodily harm to himself. ██████████ was taken into protective custody under the Baker Act and transported to ACT without incident.
