via dispatch, the subject who was later identified as (V1), was armed with a gun and
stated "if Law Enforcement is called there will be a shootout". Sgt. Teske who was aware of the above
information, requested Lake County Sheriff's Office to respond and make contact with
(R1), in order to confirm the suicidal statements. The statements were confirmed by Lake County. A
sworn written statement was not completed since was located in Lake County. It is unknown if
Lake County had complete a sworn written statement. Deputies arrived on scene and strategically

come on". Based on the physical evidence and posting, Deputy Galarza feared was likely to
cause substantial harm to himself without immediate treatment or care and was unable to determine if
treatment was needed. was placed in protective custody under the Baker Act statute and later
transported to Stewart Marchman Act in Daytona Beach for treatment without any further incident. It
should be noted, an RPO was completed and no firearms were recovered as did not have any.
