BWC RECORDINGOn 5-16-2020, at approximately 1839 hours, Deputy Lee was dispatched to [REDACTED], Orange City, in reference to a suspicious incident. Upon arrival, Deputy Lee made contact with [REDACTED] (R1), who advised the following information:On the aforementioned date and time, a male named [REDACTED] (O2), went to [REDACTED]'s residence at [REDACTED], and knocked on her door. Upon opening the door, [REDACTED] asked if he could see her son, [REDACTED] (O1), who was not home at the time and was at work in Ocala. [REDACTED] advised, [REDACTED] said he was going to kill [REDACTED] and the two began to exchange words. [REDACTED] told [REDACTED] she was calling the police, and [REDACTED] got into his car and left, speeding up the road. [REDACTED] further advised, [REDACTED] began, texting [REDACTED] via Facebook Messenger. In the messages between the two, [REDACTED] sent a picture of a gun and stated, he was going to kill him, then go back to his house and kill his mother. The firearm appeared to be a S&W M&P shield. [REDACTED] attempted to make contact with [REDACTED] via cell phone but was unable to come in contact with him. [REDACTED] did not wish to pursue criminal charges against [REDACTED] but wanted him trespassed. [REDACTED] completed and signed a VSO sworn written statement. Deputy Lee provided [REDACTED] with a VSO business card with a case number and advised her to have [REDACTED] call the Sheriffs Office, when he arrived home. Deputy Lee responded back to [REDACTED], in an attempt to make contact with [REDACTED] Upon arrival Deputy Lee made contact with [REDACTED] who advised he was at work when [REDACTED] began to send threatening messages along with a picture of a firearm, via Facebook messenger to him. [REDACTED] stated the only reason [REDACTED] would be upset with him, is because he was speeding in front of his house approximately a week ago. Overall, [REDACTED] gave a very similar account of the incident as [REDACTED] told deputies. [REDACTED] did not wish to pursue criminal charges. [REDACTED] would not complete or sign a VSO sworn written statement, however he verbally swore and affirmed his verbal statement was true to the best of his knowledge. Due to the implied firearm, an RPO was completed on [REDACTED] and sent to a legal advisor for further review. Case Status: Exceptional/Adult


