advised she was in a verbal argument with her husband, advised advised was				
consuming alcoholic beverages throughout the day and was intoxicated.				
suffers from PTSD and was acting beyond his normal manner and he was more angry tonight.				
stated during the argument began to throw things around in the bedroom and was yelling at to leave the residence. advised she then left the bedroom to call law enforcement for

advised then took the rifle away from and and then exited the residence to wait				
for deputies to arrive. advise she was not injured during the incident. completed a sworn

and believed pulled the trigger. advised when he unloaded the rifle there was a round of

completed a sworn written statement advising he did not wish to pursue charges. Deputies then set up a				
perimeter around the apartment building. Due to being armed with a rifle and having multiple				
other rifles at his disposal, coupled with the lack of good cover positions, Deputy Skrzypinski deployed				
his agency issued Mavic 2 drone equipped with a PA speaker. Deputy Skrzypinski positioned his drone to				
the rear of the residence and gave verbal commands for to exit the residence which yielded				
negative results. Deputies with the assistance of Air1 and K9 then approached the residence.				
exited the residence, complied with deputies commands and was arrested. advised he did not				
wish to speak with deputies. It should be noted while speaking with Deputy Skrzypinski could				
smell the odor commonly associated with an alcoholic beverage coming from breath. Based				
upon the above statements and evidence observed, Deputy Skrzypinski determined to be the				
primary aggressor. While in custody advised Deputy Skrzypinski he no longer wished to live and				
made several suicidal statements while being taking into custody asking arresting deputies to just shoot				
him.
