1. {Name of Respondent} ██████████ poses a significant danger of causing personal injury to himself/herself or others by having a firearm or any ammunition in his/her custody or control or by purchasing, possessing or receiving a firearm or any ammunition. The following specific statements, actions, or facts give rise to a reasonable fear of significant dangerous acts by the respondent:

On 06/29/2021 at approximately 2245 hours Deputy Mendoza was dispatched to ██████████, Osteen in reference to a suicidal subject. The information was recieved by Seminole County Sheriffs Office Deputy Kouroumous. Deputy Kouroumous advised ██████████ (V1) was at a bar in Seminole County when he told the bartender he was going to kill himself.

Deputy Kouroumouis advised ██████ was in a black truck bearing FL Army Specialty Tag ██████ that was registered to a Mazda. Deputies responded to ██████, Osteen in attempt to locate ██████ as that is his listed address on DAVID. Deputies arrived and made contact with the homeowners who advised they bought the house approximately seven months prior and ██████'s new residence was ██████ ██████ Osteen. While Deputies were Bolo'ing the area, Deputies made contact with ██████ who advised he was the Uncle of ██████. ██████ advised he had made contact with ██████ on 06/29/2021 at approximately 2240 hours at ██████'s friends residence at an unknown location after ██████ had left the bar. ██████ stated ██████ told him he was going to either wrap his car around a tree, shoot himself in the mouth, or attempt suicide by cop. ██████ advised ██████ had then left the residence to an unknown location with a .22 caliber rifle. ██████ advised ██████ drives a Black in color Toyota Tacoma with a black bed topper and one of the three back windows was broken. ██████ completed a sworn written statement.

████████ advised he believes ██████ has several mental health issues to include Bi-Polar and Schizophrenia.

These mental health issues were never confirmed.

Deputies attempted to locate ██████ at ██████ with the assistance of Air One but was met with negative results. While deputies were leaving the area, Deputies observed ██████'s truck to be parked at the Osteen Diner. With the assistance of Alert One and Drone Operator Deputy Skrzypinski the truck was cleared. Inside of the truck a brown in color Remington .22 Rifle Model 550 bearing no serial number. The rifle was located on the front passenger seat. The rifle was submitted into evidence.

The truck was towed by C&S Towing to their yard.

████████ was not located and Deputy Kouroumouis input ██████ into FCIC/NCIC as a Missing and Endangered adult.

An RPO was completed by Deputy Manzione
