██████ stated her mother ██████████ (V1), made some concerning statements. According to ████████ ██████████ suffers from depression and has an 7 extensive list of medical ailments. ████████ claimed, ██████████ threatened to shoot herself, which she also mentioned she would shoot ████████ and their 8 dog. ██████████ informed Deputy Johnson that ██████████ does not have any access to firearms, however there are firearms in ██████████ room, which are 9 secured. ██████████ had no further information to provide in reference to this incident.

Deputy Johnson made contact with ██████████ who denied making any suicidal statements. ██████████ admitted to being depressed due to family issues. ██████████ had no further information to provide.

While on scene, Deputy Johnson noticed ██████████ appeared to be overwhelmed. Due to the aforementioned information, Deputy Johnson determined without further psychiatric evaluation, there is a substantial likelihood that ██████████ will harm herself or others. ██████████ was placed into protective custody under the Baker Act Statue. It should be noted, ██████████ is on 24-hour oxygen, therefore she was transported to Fish Memorial Hospital in Orange City by EVAC.

With the statements made by ██████████ were involving a firearm and doing harm to herself and others, a Risk Protection Order was completed.
