residence and secure the remaining firearms, in which she refused.
Deputy Fowler submitted the AR-15 style rifle, the 90 round "drum" magazine and silver .380 handgun
magazine into District 4's Evidence locker as Evidence. An inventory of
CCW permit which was submitted into District 4's Evidence locker. Deputy Fowler's investigation
revealed, intentionally, unlawfully threatened by word or act, by pointing a firearm and
