

On 05/28/2022 at approximately 1330 hours, Deputies responded to be a second Deltona in reference to a person shot. Prior to arrival, Deputies were made aware **Second**, had shot his brother **Second** during a dispute about **Second** motorcycle. Upon arrival, Deputies secured **Second** and medical personnel transported **Second** to CFR due to his gunshot wound on the upper right leg. **Second** was later transported to the District 4 Office.

Detectives St John and Medina responded to the District 4 Office (1691 Providence Blvd., Deltona) and contacted Detective Medina advised **Sector** of his constitutional Miranda Rights, which he stated he understood and wished to speak with Detectives. **Sector** stated the following:

On 05/28/2022 at approximately 1100 hours, who was not at his residence, received an alert on his phone, notifying him his garage door had been opened. After review of the camera footage, which is brother to be entering his residence without permission via his garage door. I had just been released from jail for unrelated offenses, which led to believe he was there looking for somewhere to sleep.

At approximately 1230 hours, **and** received a second alert from his camera system, which led him to believe **and** was leaving the residence. **and** later returned home at approximately 1300 hours, and observed **and** car was still parked in his driveway. **The** then opened his garage door and noticed his Suzuki Motorcycle bearing FL tag: **and** was missing. **The** called his sister **and** beland who informed him **and** was in Deland at her apartment (**and** beland) and after looking outside, **and** confirmed **b** was on the way to collect the Motorcycle, but **and** left the apartment building on the motorcycle shortly thereafter. 
During **Sector**'s travels towards **Sector**'s apartment, he observed **Sector** on the Motorcycle near N Woodland Blvd. and SR 472 in Deland. **Sector** followed **Sector** back to his residence at **Sector** where **Sector** pulled into the garage and began to park the motorcycle. **Sector** proceeded to park his car in the driveway and pushed **Sector** off of the motorcycle, causing **Sector** and the Motorcycle to fall on the floor. **Sector** then engaged in a brief physical altercation with **Sector** until he was able to push **Sector** out of the garage. **Sector** verbally instructed **Sector** to leave his residence multiple times, which **Sector** and approaching **Sector** out of the garage and told him to go. **Sector** was cussing at **Sector** and approaching **Sector** At this time, pulled his CZ 9mm handgun out of his jacket pocket and fired at **Sector** striking him on the upper right leg. **Sector** then retrieved inside the residence and stored his handgun in his bedroom. later allowed Detectives access to his home security system, which confirmed the following: was shown starting a physical fight with shares and both brothers got into a mutual physical altercation. At some point, shares slams against the wall several times and pushed him out of his garage. Both brothers continue to exchange words and slapped in the face with an open hand. Then ran out of the garage with stars running behind him. Both brothers were out of camera view but continue to talk to each other. was heard on the video footage to telling stars "get the fuck out of here". was heard on the video footage to telling stars "get the fuck out of here". then pulled the handgun out of his jacket and shot shit", while walking back into the garage. then pulled the handgun out of his jacket and shot stars in the leg. At no time during the physical fight did splay or use any weapons other than his hands. any weapons on his person either. This video was recorded and a copy of the contents were later submitted into the District 4 evidence locker as evidence.

Due to the aforementioned information, **sectors** confession coupled with the video footage of the incident, Detective St John determined there was probable cause to believe **sector** committed the offense of aggravated battery with a deadly weapon.
