| Deputy Blum got in contact with the company that owns the recorded line, which revealed a audio recording of the conversation between and the telecommunicator. Deputy Childs heard call the service on his cell phone in order to speak to the debt collector about recent charges. The debt collector advised to explained his father had passed away due to act as if he was his son, explained his father had passed away due to Covid and could not pay the payment they were trying to collect. He proceeded to say "if you keep bringing up these bad memories, I'll go crazy. I might shoot up a school or something." The statements made to Deputy Childs were not consistent with the audio recording provided by the debt collecting company. |
