Prior to arrival, Deputies were made aware that _____ (V1) suffers from bipolar disorder and has been off his medication for approximately one month. Deputies were further advised _____ was making statements about wanting his \$30,000 dollars worth of guns from his gun safe within the residence and if he does not

It should also be noted Deputies were out at this residence several times throughout the night prior and today reference _____ and his wife, _____ (R1) having civil disputes over him damaging marital property. _____ did not meet baker act criteria during Deputies encounter with him today prior to this incident.

Upon arrival, Deputy King made contact with _____ near his garage and attempted to ask him what was going on and he stated the following.

_____ advised his wife would not give him his stuff and that he did not want to speak with Deputy King. _____ continued with calling Deputy King a "bitch" and that he was going to get gas for his truck from the garage. _____ began throwing items throughout the garage and asked if Deputy King "knows how to read and write" when she asked him why she was there.

Deputy King observed _____ to be highly agitated and also observed a pocket knife in his shorts front pocket while attempting to speak with him. Deputy King further observed _____ making several statements that did not make sense. Deputy King continued to try and keep conversation with _____ while waiting for another unit to arrive on scene before attempting to take him into custody under the Baker Act in attempt to avoid further physical escalation. Deputy King knew through her training and experience the body language and verbal statements _____ was making, he would not willingly go into custody without resisting.

Due to _____s obvious altered mental status, his erratic behavior causing his family to be in fear, Deputy King determined _____ met the criteria to be placed into protective custody under the Baker Act.

After approximately five minutes of Deputy King attempting to talk with _____, Deputy Bacon arrived on scene. Deputy King made Deputy Bacon aware that they needed to take _____ into custody. When Deputy King and Deputy Bacon went hands on with _____ he immediately began tensing up and resisting their commands. Deputies continued commanding _____ to give them his hands but he refused and during the struggle all three went to the ground. During Deputies struggle with _____ he continued refusing to give Deputies his hands which made Deputy King's concern grow higher due to her knowledge of _____ having a pocket knife within

within his reach. Due to [REDACTED] noncompliance, ability and opportunity to grab said knife, Deputy King gave him a warning while displaying her agency issued taser and demanded [REDACTED] provide Deputies his hands. [REDACTED] continued resisting Deputies commands and with Deputy King's agency issued taser, drive stunned [REDACTED]'s right arm while demanding he comply. After Deputy King's initial drive stun, Deputies were able to get [REDACTED] on his stomach from his back and continued attempting to get his arms with negative results. Deputy King drive stunned [REDACTED] right shoulder blade with still no compliance. Deputy Oldham arrived on scene to assist Deputy King and Deputy Bacon. Deputies were able to successfully take [REDACTED] into custody at that time with him continuing to be non compliant. Deputies rolled [REDACTED] on to his butt from his stomach, standing him up on his feet then escorted him to a patrol vehicle.

Furthermore, Deputy King made contact with [REDACTED] who advised the following.

[REDACTED] advised since Deputies left her residence this morning, [REDACTED] returned to their residence cutting the power off and vandalizing more of their property. [REDACTED] further advised she is in fear due to [REDACTED] unpredictable behavior and him refusing to take his medication. [REDACTED] completed a sworn written statement.

[REDACTED] was later transported to Halifax Hospital in Daytona Beach for further mental evaluation.

3. Affiant is is not aware of any existing protection order governing the respondent under any applicable statute.


