Advised she made a video on her cell phone where she was holding her hand gun, a pink 9mm SCCY semi automatic pistol, bearing serial number against her chest but not pointed at herself. Advised she was fearful and sent out this video to anyone she could in order to seek help. Advised she was not suicidal but wanted law enforcement assistance against and Deputy Bacon then attempted to speak with who refused to provide a sworn verbal or written statement. Deputy Bacon then made contact with (R1), the father of the sent out and called due to being worried for the swell being. The her responded to the above-mentioned residence along with law enforcement. Advised has a history of suicidal thoughts and self-harm.
advised would never admit to being suicidal due to being fearful of losing her children. Advised after watching the video, he was fearful would kill herself. Completed a sworn written statement detailing what occurred. Deputy Bacon then reviewed the video sent out. Deputy Bacon observed to be going on about how about its being abusive and blackmailing her. Within the video, Deputy Bacon observed to make the following statements among others while crying: "i am a worthless piece of shit" "I have been tormented" "I can't do anything because I love my kids" "I just wish someone would help" "Because no one cares or helps anyone anymore" Based on the lack of physical evidence, Deputy Bacon determined there was no evidence of anything criminal leading up to this incident. Deputy Bacon observed cuts on the inside of some some some some some some some some
Deputy Bacon observed the cuts to be just beginning to heal, but not bleeding. Based on the above stated information, Deputy Bacon determined that without care or treatment, could cause serious bodily harm to herself or others as evident by recent behavior. Deputy Bacon further determined was unable to determine for herself rather examination was necessary. Deputy Bacon placed into protective custody under the Baker Act and had her transported to Halifax Health Hospital in Daytona Beach for further treatment.
