"he left his residence due to thoughts of harming himself."

Deputy King responded to the scene and assumed the investigation. Deputy King spoke with [REDACTED] and he advised the following to her.

[REDACTED] advised he suffered from depression and anxiety. [REDACTED] advised he takes medications for his diagnoses but does not feel they are working. [REDACTED] further advised he left his residence due to having suicidal ideation's.

With the aforementioned statements from [REDACTED], Deputy King subsequently placed him into protective custody under the Baker Act. Deputy King seized [REDACTED]'s Taurus 9mm handgun from the driver side door and later submitted it to the District Four Evidence Locker.

Deputy King transported [REDACTED] to SMA in Daytona Beach for further mental evaluation without incident. Deputy King later completed a Risk Protection Order for [REDACTED] and submitted it to the RPO submissions.
