Upon arrival, Deputy Arthur was able to confirm that [REDACTED] mother and father were both currently in the house with him. Deputy Arthur was able to coordinate with other deputies on scene to obtain a contact number for [REDACTED] mother and father. Deputies on scene contacted [REDACTED] (O1) and spoke with her in regards to [REDACTED] [REDACTED] stated the following [REDACTED] advised [REDACTED] did indeed have access to a handgun and that she would be willing to ask her son to come outside of the house so Deputies could talk with him. Deputies accompanied [REDACTED] back to her front door where she was able to talk [REDACTED] into coming outside of the house. Once outside of the house, Deputies were able to speak with [REDACTED] and in the process he admitted to sending the suicidal text messages to his girlfriend. [REDACTED] stated that he and his girlfriend were having an argument earlier that day and insisted that he did not plan to carry out the threats to harm himself, but instead, wanted to get a response from his girlfriend regarding his statements. Due to the nature of [REDACTED] statements and the immediate access to a firearm, Deputy Arthur determined [REDACTED] to be a danger to himself and placed him into protective custody under the provisions of the Baker Act at approximately 0034 hours [REDACTED] was later transported to SMA for further medical evaluation without incident. Case Status: Closed
