On 01/06/2021 at approximately 1630 hours, Deputies responded to ██████████ Deltona reference a mentally ill person. Upon arrival, deputies made contact with ██████████ (R1) who stated the following:

On 01/06/2021 ██████████ was dropping his ex-girlfriend ██████████ (V1), off at Wes Crile park located at 1537 Norbert Ter., Deltona. Once the two arrived at the park, ██████████ noticed ██████████ was texting someone, which prompted him to ask who and for what purpose. ██████████ responded, stating she was attempting to buy a firearm from someone, so she could blow her head off. ██████████ was distraught over losing the custody of the child the two have together earlier in the day during a court appearance. After making the suicidal statement, ██████████ then departed the vehicle and left the area. ██████████ then began texting ██████████ telling him to live a good life for their child and proceeded to give him information to her remaining finances and other miscellaneous worldly possessions. ██████████ completed a sworn written statement documenting the incident.

Deputies observed ██████████ text messages and observed them to be true and accurate.

Deputies then made contact with ██████████ at the Circle K gas station located at 1805 Elkcam Blvd., Deltona. ██████████ was visibly distraught and uncooperative with deputies, denying any suicidal statements and providing no further information. ██████████ also refused to show deputies any potential text messages regarding the incident.

Due to the aforementioned statements coupled with ██████████ behavior, Deputy St John determined there was a substantial likelihood ██████████ would cause harm to herself in the near future. ██████████ was subsequently taken into custody under the Baker Act and transported to SMA for proper care and treatment.

Due to the statements involving the use of a firearm, a Risk Protection Order was completed.
