message from at approximately 1200 hours stating the following:
"yo I need you to talk to me"
"What going on" "The literally with a leaded gue?"
"I'm literally with a loaded gun" "In my hand
"Bro you gotta answer"
answered phone call after the exchange and stated he had a loaded gun in his hand and wanted to "end it all". It told to unload the gun which did because could hear the gun unload in the background. Further stated he did not want to be here then eventually got annoyed with and hung up the cellphone. It attempted to call back multiple times but was not able to reach him again and subsequently called law enforcement. Advised stated he has been drinking and sounded very intoxicated. Due to being in Gainesville he was not able to complete a sworn written statement.
Deputy Freeborough made contact with mother, (O1), via telephone who stated she was on her way to Daytona Beach and left the house, also leaving by himself, approximately 30 minutes prior. stated her son was home alone and it was unknown if he had access to weapons. advised has been very emotional lately due to his father being in the hospital.
Deputies, and all tried to contact via telephone; however, were met with negative results.
returned to the aforementioned address accompanied by her brother (O2). Prior to deputies entering the residence, made contact with who was sleeping in his bedroom and secured a firearm which he located in a gun box that was laying by in his bed. Shortly thereafter, deputies entered the room and observed laying on his bed under the covers, deputies announced themselves eventually waking up. was extremely irritated and did not want to speak with deputies, appeared heavily intoxicated and deputies observed a half-empty vodka bottle had been consuming.
Based upon the statements made to Deputy Freeborough determined there was
