On 01/01/2023, at approximately 0835 hours, Deputy Clem responded to [REDACTED] Del in reference to a suicidal person.

Upon arrival, Deputy Clem made contact with [REDACTED] (V1), who advised Deputy Clem that he sent text messages to his ex-girlfriend [REDACTED] (R1), but wouldn't go into detail. He said he sent them because he was angry with her. [REDACTED] advised Deputy Clem that he was not a threat to anyone or himself.

[REDACTED] stated [REDACTED] has been diagnosed with PTSD, but [REDACTED] denied having any history of mental health issues. [REDACTED] emailed screenshots of the text messages from [REDACTED] to Deputy Clem for review. The screenshots read "don't you dare come to my service", meaning funeral service, "I'm fucking done with this life" and " I have no reason to keep going without you".

After speaking with [REDACTED] Deputy Clem determined without psychological evaluation and treatment [REDACTED] posed a significant danger to himself and others. [REDACTED] was placed under the protective custody of a Baker Act and later transported to SMA without further incident.

[REDACTED] gave his dad permission to take possession of his firearms for safe keeping.

Deputy Clem uploaded a screenshot of the text messages to the Volusia Sheriff's Office Digital Crimescene.

Deputy Clem submitted a request for an RPO.

CASE STATUS: Closed.

3. Affiant  is  is not aware of any existing protection order governing the respondent under any applicable statute.


