The following specific statements, actions, or facts give rise to a reasonable fear of significant dangerous acts by the respondent:

On 07/12/2023 at approximately 1847 hours, Deputies responded to \_\_\_\_\_ Deltona, in reference to a suicidal person. going to use her gun tonight because she needs to be out of the house tomorrow morning. ██████████ has been making statement since this morning, is diagnosed with Bi-Polar disorder and has a history of suicide attempts in the past by slitting her wrists. ██████████ mentioned ██████████ does have a gun with her in the garage where she stays. ██████████ saw ██████████ waving a gun around and pointing it at herself while on Facetime with her.

Upon arrival, Deputies created a receiving team and a perimeter around the home. Deputies were able to confirm with the homeowner that no one else was supposed to be in the home with ██████████. Deputies were able to reach ██████████ by phone and she agreed to come outside unarmed to meet with Law Enforcement.

While speaking with ██████████ she stated the following:

She recently learned she is being evicted and Law Enforcement will be at the home tomorrow by 0900 hours to remove her. She advised this has upset her very much as she has no where else to go and all her belongings will be on the street. ██████████ expressed being upset with her landlord. ██████████ denied making statements of self-harm and denied wishing to kill herself. She did admit she was on the phone with a friend earlier but denied knowing why they would call Law Enforcement on her. Furthermore, she stated she is a disciple of the Lord and God is only testing her and her landlord. She stated the lord speaks to her with visions and tells her what to do in life. She proceeded to state when people look at her, they are supposed to see Jesus Christ. ██████████ advised everything she is going through is God's plan for her. ██████████ admitted she does have a handgun in the garage and it is likely laying out. ██████████ did not believe she needed mental health assistance.

Edgewater Police Department responded to ██████████ Edgewater and made contact with ██████████ who completed a sworn written statement stating the following:

██████████ has been speaking all day with ██████████ who had been upset and crying. ██████████ stated she was going to kill herself via her firearm or knife. ██████████ further stated she has slit her wrists in the past and is not afraid to do it again tonight. ██████████ stated she wanted to go home to "daddy, God". During the video chat call, ██████████ observed ██████████ waving her handgun around her head and mouth. ██████████ told ██████████ that death of her and her unborn twins (which do not exist) is all a part of God's plan.

With ██████'s permission, Deputies entered into the garage and grabbed her pink purse which was on the floor near her bed. She requested to bring the purse and advised her firearm was likely inside since she did not see it on the counter. Deputies located a pink Revolver handgun to be inside the purse. The Revolver was fully loaded. ██████ refused to turn over the handgun and it was left inside the garage of the residence.

A criminal history check on ██████ yielded negative results for prior felony convictions.

Deputy Rogaliner completed a Risk Protection Order due to ██████'s statements of using a firearm for self-harming reasons.

Due to the above circumstances and statements, Deputy Rogaliner determined there to be a substantial likelihood that without care or treatment ██████ will cause serious bodily harm to herself in the near future, as evidenced by recent behavior and statements. ██████ was taken into protective custody under the Baker Act statute and later transported to Stewart Marchman for medical/ mental health evaluation and treatment.

3. Affiant  is  is not aware of any existing protection order governing the respondent under any applicable statute.
