I, *{full legal name}* DEPUTY B. RODRIGUEZ, in my position as *{job title}* DEPUTY with the *{name of law enforcement officer/agency}* VOLUSIA SHERIFF'S OFFICE, swear and affirm that the following facts are true and correct.

1. *{Name of Respondent}* [REDACTED] poses a significant danger of causing personal injury to himself/herself or others by having a firearm or any ammunition in his/her custody or control or by purchasing, possessing or receiving a firearm or any ammunition. The following specific statements, actions, or facts give rise to a reasonable fear of significant dangerous acts by the respondent:

On 09/14/2023, at approximately 1619 hours, Deputies responded to [REDACTED] Deltona in reference to a suicidal person. Prior to deputies' arrival, call notes advised the reporting person, [REDACTED] (R1), who was located in Indiana and received a call from her 13-year-old son [REDACTED] a minor, (O1), that his father showed him a gun and was going to kill himself.

After arriving on scene, deputies were able to establish a perimeter and attempted to make contact with ██████████. Shortly after arriving on scene, ██████████ was observed to be walking outside and explained the reason why his dad ██████████ (O2), was acting this way. ██████████ stated recently his father was separated from his ex-fiancée who took his truck and all his money. Also, ██████████'s other kids left due to what was going on in his life. Due to him losing everything and everyone, ██████████ showed him a gun and advised he wanted to die.

Later, ██████████ walked out of the garage on the phone with a deputy who was on scene. ██████████ was given orders to comply with deputies. Deputies approached ██████████ and was taken into custody.

██████████ was asked if deputies could go into the home to locate the firearm that was allegedly displayed to his son, and he stated no.

Based on the totality of circumstances I believe ██████████ is unable to determine for himself whether examination is necessary. Also, without care or treatment, ██████████ is likely to suffer from neglect or refuse to care for himself and such neglect or refusal poses a real and present threat of substantial harm to his well-being and it is not apparent that such harm may be avoided through the help of willing family members or friends. There is also a substantial likelihood that without care or treatment the individual will cause serious bodily harm to himself.

██████████ was placed into protective custody and later transported to SMA to be examined for treatment.





The report was later faxed to DCF and Director Carla Quann was made aware. ██████████ was later turned over to the grandmother who responded to the district.

Due to the allegations of a firearm being displayed, RPO was completed and submitted into RPO submissions.


