Deputy Martin took digital photographs of where and how the firearm was found, which were later uploaded to the digital crime scene database.
Based on the totality of the circumstances, Deputy Martin determined there's substantial likelihood that without care or treatment, would likely cause serious bodily harm to herself in the near future, as evidenced by her recent behavior.
