I, {full legal name} Taylor White, in my position as {job title} Deputy Sheriff with the {name of law enforcement officer/agency} Volusia Sheriff's Office, swear and affirm that the following facts are true and correct.

1. {Name of Respondent} [REDACTED] poses a significant danger of causing personal injury to himself/herself or others by having a firearm or any ammunition in his/her custody or control or by purchasing, possessing or receiving a firearm or any ammunition. The following specific statements, actions, or facts give rise to a reasonable fear of significant dangerous acts by the respondent:

BWC RECORDING

On November 6, 2023 at approximately 1321 hours, Deputy White responded to [REDACTED] DeLand in reference to a suicidal person. Upon arrival, Deputy White made contact with [REDACTED] (O1) who stated her son, [REDACTED] (V1) recently broke up with his girlfriend [REDACTED] (O2) and was not handling it

2. {Name of Witness} [REDACTED] provided the following information based on his/her personal knowledge:

well. Once [REDACTED] arrived at her residence, she discovered [REDACTED] in the backyard with her husband's Smith & Wesson pistol (serial [REDACTED]). [REDACTED] however did not threaten [REDACTED] with the firearm and subsequently gave the pistol to her. [REDACTED] provided no further information in reference to the incident. Deputies then made contact with [REDACTED] who advised he wanted to kill himself over the break up with [REDACTED] Deputy White made contact with [REDACTED] s sister, [REDACTED] (R1) who

advised [REDACTED] sent her a text message stating that [REDACTED] told her that she is the beneficiary of his life insurance and assets. Due to the nature of the incident, [REDACTED] notified law enforcement. [REDACTED] provided no further information. Deputy White spoke to [REDACTED] via telephone who advised she recently broke up with [REDACTED] for personal reasons. [REDACTED] further advised [REDACTED] sent her the text message as well. Deputy White reviewed the text message and observed no written threats to kill or anything involving wanting to commit suicide.

Based on the information, Deputy White determined that there was a likelihood that without care or treatment, [REDACTED] could cause serious bodily harm to himself or others. Deputy White placed [REDACTED] into protective custody under the provisions of the Baker Act statute. [REDACTED] was later transported to Stewart Marchman Facility, located in Daytona Beach for further assistance. Due to the fact [REDACTED] was in possession of a firearm during the incident and admitting he wanted to kill himself, Deputy White completed a Risk Protection Order. The firearm however was not taken due to it not belonging to [REDACTED]

3. Affiant is is not aware of any existing protection order governing the respondent under any applicable statute.




