Deputy Campbell then spoke with stated he and had been drinking today, and were arguing over her wanting to take their son to Texas.
argue more frequently than in the past, and that during these arguments she continuously threatens to kill herself. During today's argument, he was "tired of hearing her threaten suicide" and admitted to telling her to end her life. denied giving the handgun he usually carries on his person, a Glock 9MM handgun but observed her obtain his Glock 45MM handgun from the closet area of their bedroom and go out into their driveway. Once in the driveway, they continued to argue and placed the Glock 45MM to her head. At that point, he obtained and asked the occupants to watch the child. then called 911 for assistance.
Deputies then spoke with (W1) (W2) who reside at and advised that had knocked on their door with a minor, and asked them for help. When they opened the door, they observed holding a gun to her head in the driveway of and agreed to watch a minor, while contacted law enforcement. and provided sworm statements of these facts.
Deputy Campbell then determined without intervention there was a substantial likelihood would cause harm to herself or attempt to end her life. She was then officially placed into protective custody under the Baker Act. Deputies entered the residence with photograph the Glock 45MM (serial number) handgun had held to her head. Deputies retrieved it from the closet area as described. Digital photographs of the firearm were obtained and submitted to the Digital Crime Scene Database. A check through NCIC/FCIC revealed the Glock 45MM handgun was not stolen. While on scene, and at least one other Glock 9MM handgun.
