**AFFIDAVIT**

I, *{full legal name}* Deputy Lindsey Campbell, in my position as *{job title}* Deputy Sheriff with the *{name of law enforcement officer/agency}* Volusia Sheriff's Office, swear and affirm that the following facts are true and correct.

1. *{Name of Respondent}* \_\_\_\_\_ poses a significant danger of causing personal injury to himself/herself or others by having a firearm or any ammunition in his/her custody or control or by purchasing, possessing or receiving a firearm or any ammunition. The following specific statements, actions, or facts give rise to a reasonable fear of significant dangerous acts by the respondent:

On 2/5/2023, at approximately 19:05 hours, Deputy Campbell responded to _____ Deltona in reference to a suicidal person. Initial call notes indicated the reporting party, _____ (R1) was reporting his live in girlfriend was armed with a handgun and suicidal. _____ indicated he was at a neighboring residence of _____ for contact with law enforcement.

Deputy Campbell and additional deputies arrived on scene and could hear a verbal disturbance between [REDACTED] and his girlfriend, identified as [REDACTED] (V1). Due to the call notes indicating [REDACTED] was armed with a handgun, deputies obtained a ballistic shield and made a tactical approach towards the residence. Once in the driveway of [REDACTED] deputies could clearly see [REDACTED] in the driveway of [REDACTED] near a vehicle. Deputies gave clear, loud commands for [REDACTED] to show that her hands were clear a weapon. Once it was determined [REDACTED] did not have a firearm in her hands, deputies approached [REDACTED] and detained in her handcuffs. Subsequently after her detainment, Deputy Campbell conducted a pat down to ensure there were no weapons concealed upon [REDACTED]'s person, which yielded negative results.

Deputy Campbell then explained to [REDACTED] the reason for law enforcement being at the residence, to which she indicated she was already aware we had been contacted. She stated she and [REDACTED] have a son together, are currently engaged, and reside at [REDACTED] as a single family unit. Prior to law enforcement being contacted today, she and [REDACTED] had been arguing over relationship issues and his alcohol dependency. [REDACTED] has been considering ending the relationship as of recently, and had a purchased a plane ticket to visit her sister in Texas later in the week. When those details were discussed during their argument, [REDACTED] become emotional and began belittling [REDACTED]. [REDACTED] stated she began to cry and start packing a bag for her trip, causing [REDACTED] to become even more emotional. Once [REDACTED] realized she was going to continue packing, he made multiple comments that [REDACTED] should kill herself. In addition to making those comments, [REDACTED] also told [REDACTED] he did not need her and she would not be taking their son [REDACTED], a minor, (O1) to Texas with her. [REDACTED] then exited the residence and went outside to the driveway. [REDACTED] followed her outside, and told [REDACTED] she should kill herself a few more times. [REDACTED] stated at that point, she had an emotional outburst and agreed to ending her life. [REDACTED] then produced a firearm from his waist band and handed it to [REDACTED]. [REDACTED] then held the firearm towards her head and continued to argue with [REDACTED]. Prior to law enforcement's arrival, [REDACTED] stated she placed the handgun in the closet of their bedroom.

Deputy Campbell then spoke with [REDACTED]. [REDACTED] stated he and [REDACTED] had been drinking today, and were arguing over her wanting to take their son to Texas. [REDACTED] indicated that he and [REDACTED] argue more frequently than in the past, and that during these arguments she continuously threatens to kill herself. During today's argument, he was "tired of hearing her threaten suicide" and admitted to telling her to end her life. [REDACTED] denied giving [REDACTED] the handgun he usually carries on his person, a Glock 9MM handgun but observed her obtain his Glock 45MM handgun from the closet area of their bedroom and go out into their driveway. Once in the driveway, they continued to argue and [REDACTED] placed the Glock 45MM to her head. At that point, he obtained [REDACTED], a minor, from inside of the residence and took him to a neighbor's house at [REDACTED] and asked the occupants to watch the child. [REDACTED] then called 911 for assistance.

Deputies then spoke with [REDACTED] (W1) [REDACTED] (W2) who reside at [REDACTED] and [REDACTED] advised that [REDACTED] had knocked on their door with [REDACTED] a minor, and asked them for help. When they opened the door, they observed [REDACTED] holding a gun to her head in the driveway of [REDACTED] and agreed to watch [REDACTED] a minor, while [REDACTED] contacted law enforcement. [REDACTED] and [REDACTED] provided sworn statements of these facts.

Deputy Campbell then determined without intervention there was a substantial likelihood [REDACTED] would cause harm to herself or attempt to end her life. She was then officially placed into protective custody under the Baker Act. Deputies entered the residence with [REDACTED] to photograph the Glock 45MM (serial number [REDACTED]) handgun [REDACTED] had held to her head. Deputies retrieved it from the closet area as described. Digital photographs of the firearm were obtained and submitted to the Digital Crime Scene Database. A check through NCIC/FCIC revealed the Glock 45MM handgun was not stolen. While on scene, [REDACTED] and [REDACTED] revealed there were multiple firearms in the residence to include a shot gun, rifle, and at least one other Glock 9MM handgun. However, access to view these firearms was denied by [REDACTED] who started to become agitated with law enforcement's inquiry of the additional firearms. A criminal history check of [REDACTED] and [REDACTED] yielded negative results. [REDACTED] was transported to Stewart Marchman Healthcare in Daytona Beach.
