Upon arrival, _____ stated her roommate, _____ had made statements of killing herself and others. _____ stated _____ has a “hit list” of approximately nine people she was going to kill and afterwards she was going to kill herself (Deputy Walker was unable to locate the list) _____ stated she was on the list along with two unknown Holly Hill Police Officers, a Winn-Dixie manager, and other females that live in the residence. _____ also stated she was going to torture the landlord then “cut her up,” according to _____ stated this has been going on for approximately three months and over the last week it has become worse. Other roommates, along with _____ have had to move items from the living area and put them in their room due to _____ destroying things. _____ stated _____ is supposed to be taking medicine for bipolar schizophrenia; however, _____ has not been taking them.

Deputy Walker then contacted _____ in her room that’s located in the back of the residence. When talking to _____ she stated people in the house had been harassing her and giving her a hard time. She stated they recently gave her a notice she must be out in five days. _____ stated she never wanted to hurt anyone or hurt herself. _____ stated she was diagnosed with bipolar schizophrenia in 2015 but has not been given any medication.

_____ informed deputies she did not own any firearms; however, was interested in purchasing one in the future.


