AFFIDAVIT

I, *{full legal name}* JOSHUA HANSARD, in my position as *{job title}* DEPUTY SHERIFF with the *{name of law enforcement officer/agency}* VOLUSIA SHERIFF'S OFFICE, swear and affirm that the following facts are true and correct.

1. *{Name of Respondent}* [REDACTED] poses a significant danger of causing personal injury to himself/herself or others by having a firearm or any ammunition in his/her custody or control or by purchasing, possessing or receiving a firearm or any ammunition. The following specific statements, actions, or facts give rise to a reasonable fear of significant dangerous acts by the respondent:

On 04-16-2023, at approximately 2002 hours, Deputy Hansard was dispatched to a well-being check at [REDACTED] Ormond Beach, in reference to statements audio and video recorded from a residential surveillance system. Deputy Hansard contacted [REDACTED] (R1) via cellular phone, due to him not being in the immediate area. According to [REDACTED] (R1), he observed his father [REDACTED] [REDACTED] (V1) loading several firearms into his vehicle and making statements

indicating he was "Going to kill someone in the hood". Based on the seriousness of the video and the immediate threat to personal safety of the general public, ██████████ (R1) contacted the Volusia Sheriff's Office for assistance. Due to ██████████ (R1) living in the New Smyrna Beach area, District 3 South deputies assisted with obtaining a sworn written statement from him. ██████████ (R1) emailed a copy of the video surveillance recording, which confirmed the allegation of his father's statements.

Based on the seriousness of the statements made by ██████████ (V1), Deputy Hansard notified Sergeant Hattaway, whom later responded to the scene. Deputy Hansard obtained ██████████'s (V1) cellular phone number and attempted to utilize investigative means to locate him. Multiple law enforcement officers attempted to locate ██████████ (V1) at his residence, however no contact could be made. A statewide Be On the Look Out, "BOLO", was issued due to the homicidal threats made by ██████████ (V1). Eventually, once mobile in the area, an Ormond Beach Police Department officer, whom responded to assist, located ██████████'s (V1) vehicle in front of ██████████

Law Enforcement Officers in the immediate area overheard two males and a female engaged in conversation on the pack porch area of the aforementioned address, at which point contact was made with ██████████ (V1), whom was subsequently placed into protective custody under the Florida Baker Act. ██████████ (V1) was asked about the statements made on the video recording to which he confessed to saying he would "shoot people in the hood".

██████████ (V1) refused to turn over any firearms to Volusia Sheriff's Office deputies on-scene and stated he had approximately 15-20 pistols, approximately 3-4 shotguns, and 5 rifles.




██████████ (V1) was later transported to Halifax Medical Center, in Daytona Beach for further treatment and evaluation.

It should be noted an Risk Protection Order was completed for ██████████ (V1) and forwarded to the Legal Advisor for review.

3. Affiant is is not aware of any existing protection order governing the respondent under any applicable statute.




