responded with a text stating (in part), "I'm on my way home we will talk this out and fix this problem I'm not going anywhere and neither are you"
advised he returned home and found the respondent with his rifle in her lap.  advised he took the rifle from the respondent and secured it in his closet.  his 9mm handgun unloaded and secured with gun locks.  advised he always keeps both his rifle and advised his wife is not familiar with the weapons and does not know how to use them, nor does she have a key to the gun locks. Despite this fact, advised he will be securing the firearms (and associated ammunition) at another location, away from the residence, due to the recent actions of the respondent.
advised after he secured the rifle, took his basket of prescription medication and went into the bathroom. At this time, contacted the Sheriff's Office for assistance. In addition to the aforementioned information provided by he further advised has been using Marijuana heavily and he believes this is contributing to her issues.
