On Thursday, July 24, 2020 at approximately 2138 hours, Deputy Blum was dispatched to
, DeLand in reference to a disturbance with a firearm. Prior to arrival, Volusia County
Communications advised a female called in and stated her husband threatened her with a gun. The female
then advised the male was with her in the room and she placed the telephone down and the
Felecommunicator heard an argument ensue.
Televellintation in all all different elisate.
Upon deputies' arrival, the residence was surrounded and Deputy Blum moved to the northwestern corner
of the residence and gained a visual on the subjects in the living room of the residence. Deputy Blum
observed the female and the male to be arguing but no weapon was seen. Deputy Blum continued to
provide updates reference the subjects locations while communication was terminated by the
Telecommunicator with the female subject. Sergeant Lee then made telephone contact with the female
who was identified as, (V1). Sergeant Lee convinced (V1) to exit the residence and
make contact with deputies.
After (V1) was out of the residence she advised her husband, (V2), had gotten
upset with her due to her making suicidal statement hours prior, stating she wanted to commit suicide
reference financial issues. (V1) continued to advise (V2) armed himself with a silver in
color revolver and made statement that he was going to shoot his handgun and kill himself first.
(V1) called for law enforcement assistance due to her being fearful (V2) was going to commit
suicide. (V1) told Deputy Blum she was not in fear of (V2) shooting her but that he was
going to shoot himself. (V1) advised the firearm was at no time ever pointed at her.
While (V1) was being interviewed, Deputy Blum continued to observe (V2) actions.
Deputy Blum observed (V2) to be unstable on his feet and to be falling to the floor multiple times.
At one point (V2) fell into his television and his head struck the wall causing a laceration. Deputy
Blum relayed the information to Sergeant Lee who determined deputies needed to enter the residence.
Entry was made into the residence and (V2) was secured.
Deputy Blum asked (V2) what had occurred and he advised (V1) made suicidal
statements which caused him to arm himself with a firearm and threatened to kill himself first. Deputy
Blum explained the process of a Risk Protection Order to (V2) he advised he understood and
agreed to complete the process which included collecting his firearms and storing them at the Volusia
Sheriff's Office evidence facility.
After investigating, Deputy Blum determined there would be a substantial likelihood that without care
or treatment both (V1) and (V2) would likely cause serious bodily harm to themselves.
Deputy Blum placed both (V1) and (V2) into protective custody under the Baker Act.
(V1) was later transported to Stewart Marchman ACT, Daytona Beach and (V2) was later
transported to Halifax Hospital, Daytona Beach.
