On August 5th, 2020, at approximately 2338 hours Deputy White responded to DeLand
in reference to a suicidal person. While en route to the aforementioned location, central communications
advised the suicidal subject could be in a and outside of (R1)
house, possibly armed with a firearm. Deputy White arrived in the block of
and staged for additional units to arrive with the shield, however while staging Deputy White observed a
vehicle slow rolling southbound on . When it reached Deputy White, he immediately
stopped the vehicle and made contact with a white male, later identified as 's husband,
(V1). was immediately secured and placed into a VSO marked patrol car. A quick, cursory
inspection of the vehicle revealed a handgun unsecured in the passenger seat next to him.
Deputy White made contact with at who stated the following information:
stated throughout the day, was angry with her for having the bathroom remodeled and
began to accuse of cheating, to which were thing was her fault.
threatening to kill himself (around 1630 hours) through text messages. Later, while was at work,
he continued to text, stating he would kill himself if anyone got involved or told anyone about
his threats to end his life. At one point, told she was going to leave home and would
return the following morning, but warned he would "blow his brains out" in front of her
at their home and repeated he would end his life.
earlier, he stated he would, "kill us all," if she was somewhere she should not be. completed a sworn written statement in reference to the incident.
sworn written statement in reference to the incident.
Later when he got off work, at approximately 2327 hours, texted he was outside of her
grandparents house and that she should listen for a gunshot. then stopped all communication with
at 2330 hours. then sent a text to because she was unsure if was outside of
the residence.
Deputy White observed the text messages received from which stated:"I'm killing
myself tomorrow morning so be ready." "I'm making a will right now and I will end it tomorrow. You'll
get it in the mailbox." "You kick me out and I'm killing myself, Play that game and I'll do it, I'm on the
edge as we speak, Do it!!!! I will kill myself."
Digital photographs of the text messages and seems 's vehicle were taken, which were later uploaded to
the digital crime scene database.

brought the Seminole County gear to Seminole's Watch Commander Lieutenant Jo-An Eckstein and
informed her of the incident. also stated he has a Sig P320 9mm in his gun cabinet at his
residence.
Due to making suicidal statements to cause harm to himself with a firearm, a Risk Protection
Order was completed.
Based on the above information, Deputy White determined there was substantial likelihood that without
care or treatment would likely cause serious bodily harm to himself or others. At this point,
Deputy White placed into protective custody under the Baker Act. was later transported to
Stewart Marchman Facility, located in Daytona Beach for further evaluation.
Deputy White forwarded a copy of the report to Lieutenant Eckstein.
