On August 10th, 2020 at approximately 2043 hours, Deputy Liles was dispatched to
Edgewater in reference to a fight involving a firearm. Upon arrival, Deputy Liles and responded deputies
made contact with, (D1), who was detained in the driveway of the residence, due to
the fact he was suspected to be the male aggressor with the firearm. After removal of (D1)
from the area of the residence, Deputy Liles made contact with (D1) father,
(V1) who advised the following:
(V1) stated his son
back on his feet after battling drug addiction issues. (VI) advised several moments before
calling the police, he attempted to verbally instruct  (D1) to leave the residence because
(D1) had been drinking and was becoming very belligerent at the house. (V1) stated
(D1) collected some of his belongings and was going to vacate the property, however,
and placed it onto the ground where (D1) then unzipped the bag. (V1) advised (D1) then produced a black rifle style long gun and charged the weapon in what
(VI) stated as an aggressive manner. (VI) advised (DI) then pointed the weapon
towards the ground in his direction and said "I have one in the chamber for you, so don't come at me".
(VI) stated he immediately stopped where he was and stated in the moment he was fearful
that (D1) may hurt him due to the state of mind he was in. (V1) advised several
moments later, (D1) put the rifle back into the soft black case and that's when
(VI) stated he rushed towards (D1) to restrain him from getting the weapon back out.
(V1) stated grabbed the rifle bag off the ground and secured the weapon inside of the
nearby garage area. (V1) advised (D1) then went to the end of the driveway where
he was greeted by responding deputies. (V1) completed a sworn written statement detailing
the incident and signed a Marcy's Law document opting to keep his information private.
Deputy Liles then made contact with who stated he was standing outside during the entire
conflict. (D1) was arguing with his father over having to leave the
residence, when (D1) went into the garage and came outside carrying a black rifle case in his
hands. (D1) placed the rifle bag on the ground and retrieved a black rifle
style long gun from the bag. (D1) pointed the weapon in the direction of
(V1) and said "I got one in the chamber for you, so don't come near me. advised
several moments later, (D1) placed the weapon back into the carrying case and proceeded to
zip the bag back up. (V1) rushed in towards (D1) and
grabbed the bag and handed it back towards . stated he then quickly placed the
bag with the weapon inside the garage in an attempt to hide the weapon from (D1).
stated (D1) then angrily walked towards the end of the driveway where he was

met by responding deputies. completed a sworn written statement detailing the incident.
All parties on scene refused medical attention.
Deputy Liles collected the automatic rifle (serial #
was located inside the garage in a soft black case. No magazines were located on scene or inside the bag.
Deputy Liles did locate two .223 rounds in the grass near the driveway where (D1) took the
weapon out earlier. The rifle, ammo, and gun case were collected as evidence and later transported to the
District 3 evidence locker.
(D1) was read his constitutional rights once placed under arrest and did not wish to speak
until having an attorney preset.
