I, *{full legal name}* Michael McGinnis, in my position as *{job title}* Deputy Sheriff II with the *{name of law enforcement officer/agency}* Volusia Sheriffs Office, swear and affirm that the following facts are true and correct.

1. *{Name of Respondent}* ██████████ poses a significant danger of causing personal injury to himself/herself or others by having a firearm or any ammunition in his/her custody or control or by purchasing, possessing or receiving a firearm or any ammunition. The following specific statements, actions, or facts give rise to a reasonable fear of significant dangerous acts by the respondent:

On 08/23/2020, at approximately 1806 hours, Deputies responded to a suspicious incident where there was a threat made with a firearm. Contact was made with the victim, who works for the respondent's mortgage company. The victim arrived to the property and was threatened by the respondent with a firearm. The respondent made the victim get on the ground and put a silver revolver to his head and fired a single shot into the ground.

2. *{Name of Witness}* ██████████ provided the following information based on his/her personal knowledge:

██████████ advised the victim approached the residence and handed her a piece of paper pertaining to their mortgage. ██████████ then witnessed her husband walk down their driveway holding a firearm in his hand. ██████████'s husband then began to approach the victim and at one point fired a single shot into the ground.
