MK III bearing serial# J84662 was inspected. Upon inspection (6) six brass bullets were located in the
cylinder. No spent shell casing were observed in the cylinder, or anywhere on the property. Deputy
Kretzer assisted Deputy Bartzer by inspecting the property, vehicles, and the boat, no of which displayed
in projectile strikes or bullet holes. Based on the statements provided by
video provided by Deputy Bartzer determined there to be probable cause to charge with
Aggravated Assault with a Deadly Weapon. A criminal history check was ran on which revealed
has no felony or misdemeanor convictions. Due to a firearm being involved a Risk Protection Order
was completed and forwarded to the Volusia Sheriff's Office Legal Advisor.
