| backyard fence. At the conclusion of the deputy's investigation that day, he noted, "Nothing criminal. |
| Property never taken. Lights not working as RP would like. All residents and out of state family member |
| still MIP." |
| Upon Deputy Borbely's arrival to this day, he first made contact with who advised the |
| following: She stated located next door at located |
| her roof. was under the delusion of hearing 's children on her roof. alleged the children |
| from shome tamper with her cameras so she is unable to document them on video surveillance |
| entering her property. stated in addition they have tried to enter her bedroom. denied exiting |
| the home with a firearm in her possession. does not have sfamily documented on her home |
| surveillance of entering her property. has previously made multiple allegations of her neighbors on |

| rape her" which were determined to be untrue. |

| Deputies have previously determined her allegations are unfounded and are based on a paranoia of harm |
| that is not true. Deputy Borbely contacted at his residence of . stated he was |
| uncertain of the object in stated he has had multiple encounters with yelling |
| various accusations at him and his family. advised they try to ignore in order to prevent her |
| from becoming agitated. believes to be schizophrenic due to her outlandish allegations and |
| paranoid behavior. Deputies contacted regarding the incident. made statements similar |
| to which correlates to mental illness. showed Deputies the firearms him and |
| possess. Deputies were showed a Taurus G2C 9mm bearing serial number THS94808 and a Heritage .22 |
| revolver bearing serial number: R158176. disclosed to Deputies he was waiting on ammo to |
| arrive and said he would start "shooting at the shadows." Deputy Borbely spoke with |
| together regarding neighborhood concerns and firearm safety. While Deputy Borbely was explaining |
| safety concerns, stated "you better tell them to stay out of this yard because there will be bullets |
| fired, starting tomorrow." and were agitated and were not receptive to Deputies |
| suggestions. |
