I, {full legal name} Dejhan Johnson, in my position as {job title} Deputy Sheriff II with the {name of law enforcement officer/agency} Volusia Sheriff's Office, swear and affirm that the following facts are true and correct.

1. {Name of Respondent} [REDACTED] poses a significant danger of causing personal injury to himself/herself or others by having a firearm or any ammunition in his/her custody or control or by purchasing, possessing or receiving a firearm or any ammunition. The following specific statements, actions, or facts give rise to a reasonable fear of significant dangerous acts by the respondent:

On 11-26-2020, at approximately 1755 hours, Deputy Johnson responded to [REDACTED], Deltona in reference to a disturbance. Upon arrival, Deputies made contact with [REDACTED] (VI) who advised the following information:

[REDACTED] claimed he was sitting on the front porch at the above address, when he was approached by [REDACTED] (DI). [REDACTED] stated [REDACTED] asked him to come inside, so he could talk to him. [REDACTED] mentioned, when he walked into the residence, [REDACTED] met him at the door, which is when he brandished a firearm and placed the barrel of the firearm under [REDACTED] chin. [REDACTED] described the firearm to be a big silver revolver. During this incident, [REDACTED] advised [REDACTED] appeared intoxicated, when he was asking where his money was located.

Shortly thereafter, [REDACTED] stated [REDACTED] placed the firearm down on table, which was located near the front door. [REDACTED] advised [REDACTED] went to search for his money once again, which is when he found the money. After this incident, [REDACTED] left the residence. Deputy Brown made contact with [REDACTED] via Facetime, because he did not want to come back to the residence. [REDACTED] stated he did not wish to pursue charges and had no further information in reference to this incident.

Deputy Johnson made contact with [REDACTED] (W1) who is a resident at [REDACTED]. [REDACTED] stated she was made aware that this incident took place by [REDACTED] who is her nephew's boyfriend. [REDACTED] advised she had video surveillance of the incident, which was captured on a camera in her living room. [REDACTED] forwarded Deputies a copy of the video surveillance, but she had no further information to provide.

Deputy Johnson made contact with [REDACTED] who was read his Constitutional rights from an VSO agency issued Miranda card, which [REDACTED] advised he understood and waived his right to legal counsel, agreeing to talk with Deputies.

[REDACTED] stated he was missing \$800 and believed [REDACTED] took the money. According to [REDACTED] he was highly upset and had a strong belief [REDACTED] stole his money. [REDACTED] admitted to brandishing his silver revolver at [REDACTED] in efforts to retrieve his money back, which was consistent with the statement [REDACTED] provided. [REDACTED] stated [REDACTED] told him he did not have the money, which is when [REDACTED] went to search for the money again. [REDACTED] claimed he found the money and apologized to [REDACTED]. According to [REDACTED] he was scared at that point and hid the revolver. [REDACTED] claimed he did not remember where he placed the firearm, because there was so much going on at the time. [REDACTED] claimed he believed it was in [REDACTED] room, but he could not find it. [REDACTED] had no further information to provide.

While on scene Deputy Johnson observed ██████████ had an odor of alcohol emanating from his person. Deputy Johnson further observed ██████████ was in a hurry to "go home".

Deputy Johnson reviewed video surveillance, which the following observations were made:

Deputy Johnson noticed at the 10 second mark in the video, ██████████ appeared in the footage walking with what appeared to be a firearm in his left hand. Deputy Johnson observed ██████████ walk towards the front door, where he placed the firearm down on a table nearby. ██████████ was seen stepping outside the front door, as if he were speaking to someone. ██████████ stepped back into the residence and closed the door behind him. Shortly thereafter, ██████████ was observed walking in the home through the front door. ██████████ was observed quickly grabbing the firearm from the table and concealing it behind his back with his left hand. At approximately the 34 second mark, ██████████ was observed brandishing a silver revolver, which he placed the firearm under ██████████ chin. During this incident, ██████████ was asking ██████████ about the money he is missing. ██████████ was observed for approximately 30 seconds brandishing the firearm at ██████████

██████████ advised ██████████ was not a resident of the home, and was a temporary guest staying with her for a short time. While on scene, ██████████ gave consent for Deputies to search her residence in efforts to locate ██████████ firearm, but yielded negative results. Deputy Johnson will be generating a risk protection order, in attempt to take possession of any and all firearms owned by ██████████ Deputy Johnson contacted Central Communications and had them do a criminal history check, which yielded no records found.

Deputy Johnson's investigation yielded the following results: Deputy Johnson observed ██████████ admittance to brandishing the firearm at ██████████ which was consistent with ██████████ statement. Video surveillance provided by ██████████ which clearly shows ██████████ holding a firearm under ██████████ chin. Based on the totality of the circumstances, Deputy Johnson determined probable cause existed to arrest ██████████ for aggravated assault with a deadly weapon.

██████████ was transported to the VCBJ without further incident.
