On 12/11/2020 at approximately 1826 hours, Deputy Connor responded to ,
Deltona, in reference to a disturbance. Prior to arrival Deputy Connor was informed that while the
reporting party (RI) was on the phone with dispatch, there a was a male in the background
yelling " just send me an ambulance", " you better send someone here or I am going to kill her", " I cannot
deal with my mom, I'm not in my right state of mind, I don't want to hurt her."
Upon arrival, Deputy Estrada advised dispatch to have step outside to speak with deputies. Deputy
Connor made contact with who advised her son (V1) has not been acting himself
since his recent brain surgery. stated is not supposed to be drinking but had a few beers prior
to deputies arrival. While speaking with there was a slight language barrier and Deputy Connor
had to ask several times where was in the house, and would not disclose his location.
eventually advised was in his room and should not have any weapons.
walk back into the residence while speaking with deputies and eventually made it in through the front
door. Once inside yelled for who stated "get out of the house, I am loading up to shoot."
Deputies immediately escorted out of the residence and off the property. Deputy Connor took hard
cover behind a few trees, and noticed lights were being turned off inside the residence. After a few seconds was observed standing in the doorway of the residence. Deputy Connor began to give
commands for to put his hands up to which replied "fuck you." Deputy Connor attempted to
make dialogue with who kept repeating "there is only one way out of this, you're going to have to
shoot me." After a few minutes of speaking with Deputy Connor was able to have step out of
the residence where Deputy Connor could visually confirm that did not have any firearms on his
person. While Deputy Connor was speaking with other deputies were forming a receiving team to
approach Deputies were able to have turn around and walk back to them where deputies ran
up and tackled to the ground where he was detained. Once detained began to disclose that he
has hit a hard patch in his life, with completing school to work on A/C units but can not find a job, and
possibly being evicted from the residence. It should be noted, just recently had brain surgery, he is
bi-polar, and has consumed alcohol when he should not have. was informed he would not be going
to jail to see a doctor instead. agreed with the decision to speak with a doctor about what he has
been going through. It should be noted was not injured during the incident and did not need
assistance from Deltona Fire Rescue. Based on the statements and observations made, Deputy Connor
determined that without proper care would become a harm not only to himself but a harm to others
as well. was taken into custody under the Baker Act and transported the Stewart Marchman in
Daytona Beach for further evaluation. Based on the statements made by about a firearm, Deputy
Connor completed the appropriate paperwork for an RPO (Risk Protection Order).
