On 12/18/2020 at approximately 0742 hours Deputy Crofutt responded to ██████████, DeLand in reference to a suicidal subject. Deputy Crofutt arrived on scene and made contact with ██████████ (VI) who advised he was suicidal. ██████████ further expressed he wanted to shoot himself in the head with a firearm. It should be noted ██████████ advised he does not have any access to firearms but states he would find one if needed. Deputy Crofutt determined there is a substantial likelihood that without care or treatment ██████████ will cause serious bodily harm to himself or others in the near future, as evidenced by recent behavior. Deputy Crofutt placed ██████████ into protective custody under a baker act. It should be noted due to the nature of the threats a Risk Protection Order was completed and submitted to the legal advisor.


