AFFIDAVIT

I, *{full legal name}* Joseph Borbely, in my position as *{job title}* Deputy Sheriff II with the *{name of law enforcement officer/agency}* Volusia Sheriff's Office, swear and affirm that the following facts are true and correct.

1. *{Name of Respondent}* ██████████ poses a significant danger of causing personal injury to himself/herself or others by having a firearm or any ammunition in his/her custody or control or by purchasing, possessing or receiving a firearm or any ammunition. The following specific statements, actions, or facts give rise to a reasonable fear of significant dangerous acts by the respondent:

On January 31, 2020 at approximately 2215 hours, Deputies were dispatched to ██████████ ██████████ Deltona in reference to a 911 call initially dispatched to Orange City Police. Prior to arrival, VSO Communications was in contact via phone with an irate female advising she was being stalked by a cop in a parking lot. VSO Communication call notes indicate she was extremely irate with the call taker and was screaming and

cussing. VSO communication notes indicate the female stated she is a veteran and how she felt unimportant by the call taker. Call notes at approximately 2209 indicate the female stating a deputy would shoot her and place the gun in her hand to make it look like she did it. Additional notes at approximately 2212 hours state the female called back upset with the prior call taker and stated VCSO does not care about suicidal veterans and that they are going to have another dead veteran on their hands. The caller, later identified as [REDACTED] (VI) was contacted at her [REDACTED] residence. Upon arrival, Deputies made multiple attempts to contact [REDACTED] at her residence. At approximately 2251 hours, Deputies heard [REDACTED] crying indoors who later responded to Deputies at her front door [REDACTED] denied making her statements and was uncooperative with Deputies attempts to check on her well being. [REDACTED] stated she was in the residence by herself with only her two dogs present. Deputies were able to link [REDACTED] s phone calls to the residence and asked if she would provide a voluntary examination after an explanation was provided. [REDACTED] refused a voluntary examination. It should be noted, [REDACTED] is a military veteran with service in the United States Army. Due to the phone calls [REDACTED] made, Deputy Borbely determined without proper care or treatment, there was substantial likelihood [REDACTED] would be a harm to herself or others. [REDACTED] was placed into protective custody under the Baker Act and was transported to Halifax Hospital without further incident. Deputy Borbely completed the appropriate Risk Protection Order (RPO) paperwork which was forwarded to the VSO Legal Advisor for review.
