stated he drove to the fire station to commit suicide because he did not wish to leave a mess at his own residence. Additionally, has been struggling with anxiety and depression for over three months and woke up at 0400 hours this morning feeling suicidal. voluntarily relinquished his firearm, which he stated was inside of the center console of his vehicle. Deputies located the firearm inside the center console of the vehicle and later placed the 9mm Taurus handgun and seven bullets into the District 6 Evidence Locker. Deputies ran the Taurus PT709 firearm bearing serial number: TDM32054 through VSO TeleType which
revealed the firearm was negative for wants.
Deputy Cunningham determined without proper care or treatment, was likely to suffer great bodily harm to himself. Subsequently, was placed into protective custody under the Baker Act and transported to Stewart Marchman in Daytona Beach for further evaluation.
A Risk Protection Order was completed in reference to this incident.
