On 10/04/2021, at approximately 1825 hrs., deputies were dispatched to the province of the pro
reference to a suicidal person. The initial call notes advised (R1) was calling in advising
(V1) was sitting in her truck (Rlack F-150), armed with a small
handgun; threatening to commit suicide. While was on the phone with dispatch, advised he heard what sounded like a gunshot go off. advised he was inside the residence and could see

movement inside the truck, which was parked in the driveway of the aforementioned residence. It was
later learned had discharged one single round through the front passenger window (window was
rolled down) which struck a tree that was located directly near the truck.
suffered from depression. Upon arrival, Deputy Galarza observed the black F-150 parked in the driveway.
Before deputies converged on the truck, exited the truck via the front driver side with her hands
in the air walked to the back tailgate of the truck and sat on the pavement. was placed
in handcuffs without incident and placed in the backseat of a patrol car. was uninjured and
declined medical attention. Contact was made with who advised the following:
advised his mother showed up at his house, banging on the front door, all while crying and alluding
to suicide. advised his mother suffers from depression and stated she was in the process of losing
her house. advised he followed his mother back outside to her truck. Once inside the truck,
rummaged through the center console and produced a pistol (Buffalo Arms .357 Magnum Model
1 serial # 5654), proclaiming "I found it". Upon seeing this, went back inside the house and dialed
911. Completed a sworn written statement pertaining to this incident. Deputies located the handgun
sitting in the front passenger seat of the truck. Deputies observed a bullet fragment lodged into the tree.
No spent shell casings were located nearby.
atatad also had the
Deputy Galarza spoke with who when asked about the handgun, stated she had the
intentions of killing herself. explained no one cared about her and that she was losing her house
and had nothing to live for. advised she did not remember if she discharged the handgun.
was placed in protective custody under the Baker Act Statute and was later transported to
Stewart-Marchman-Act (Daytona Beach) for further evaluation without incident.
Deputy C. Jones took possession of the handgun and completed an RPO. A criminal history revealed
does not have any felony convictions
