and advised he left his firearm on the rear porch. While with deputies, was very apologetic and
stated "I'm sorry I made you guys do this".
Deputy Hill then made contact with (O1) who advised she was in good health and was not
harmed during the incident. explained her husband was watching a documentary about
Vietnam and it made him very upset. So upset infact that went to the store and bought cigarettes
which was not normal for him. further explained told her that he was "just tired of it all".
then told to stop watching the documentary since it made him upset and at that point she
thought that was the end of it. advised she was not aware that retrieved his firearm nor did
she think he was suicidal.
