On 12/21/2021 at approximately 1735 hours Deputy Girdwood responded to ██████████, Osteen in reference to a possible attempted suicide. The initial calls notes advised ██████████ (R1) was calling in advising that her adult son, ██████████ (VI) walked into the woods behind their house, armed with a handgun. Additionally, ██████████ advised she then heard a single gunshot coming from the wooded area ██████████ was seen walking into. ██████████ advised that her son was severely depressed and believed ██████████ may have shot himself but was afraid to check the woods to confirm.

Deputies arrived on scene and began scanning the property in attempts to locate ██████████ Deputy Hachenberger deployed his department issued drone and was able to locate ██████████ in the wood-line west of the residence, unresponsive laying in the supine position. Deputies made contact with ██████████ who appeared to be having a medical episode. ██████████ appeared to be foaming at the mouth and violently shaking. ██████████'s right arm was laying across his stomach and a revolver (S/N:109634 .38 Special) was found to be laying between his left arm and body. Deputies were able to roll ██████████ over and place him in handcuffs. ██████████'s body did not show any signs of having any gun shot wounds or any other weapons on him. Let it be known that the revolver had one empty casing in the rotating cylinder from a round being fired and four other rounds that were not yet fired.

Deputy Girdwood made contact with ██████████ in regards to what occurred prior to ██████████ walking into the woods. ██████████ advised that ██████████ had been arguing with her about his drinking habits. ██████████ advised that ██████████ had been suicidal and has been an alcoholic for the past twenty plus years. ██████████ advised that ██████████ began to pack his clothes and personal belongings to go to his girlfriends house and requested his revolver from his father. ██████████ advised that the father gave ██████████ the revolver thinking he was taking it with him. ██████████ then made a comment to his father, "I wont need any of my clothes anymore" and walked out towards the woods. ██████████ advised that she then heard a single gunshot momentarily after ██████████ walked out towards the woods. ██████████ advised the refused to look for ██████████ in the woods due to having another son of hers commit suicide in their residence in the past. ██████████ advised ██████████ suffered from depression and prior to walking out of the residence, ██████████ made several comments alluding to him committing suicide.

It was determined that without proper care or treatment there is a substantial likelihood that ██████████ would cause harm to himself. ██████████ was placed in protective custody under the Baker Act and transported to Central Florida Regional Hospital located at 1401 US-17S Sanford, 32771 for medical treatment. An FCIC/NCIC query of the firearms serial number was conducted which revealed no record found. Deputy Girdwood conducted a check of ██████████'s criminal history which revealed no felony convictions. Deputy Girdwood collected the handgun, the four unspent shell casings, along with the spent shell casing; which were submitted to District Four Evidence Locker, as evidence (under the RPO paperwork). Deputy Girdwood completed the appropriate Risk Protection Order (RPO) paperwork which was forwarded to the VSO Legal Advisor for review.
