As Deputy Adamczyk was notifying dispatch of the location and information provided, Deputy Adamczyk saw two males walking from the area indicated by [REDACTED]. Deputy Adamczyk was able to call the males towards Deputy Adamczyk's location. [REDACTED] (O1) identified himself as the person who [REDACTED] had called about and then stated he was not suicidal. [REDACTED] (O2) walked away from [REDACTED] as Deputy Adamczyk communicated with [REDACTED]. [REDACTED] complied with directions to pull up his shirt and turn in a manner which allowed Deputy Adamczyk to see he was not concealing a firearm in his waistband or shirt. [REDACTED] walked towards Deputy Adamczyk stating he was "stressed out" and had been evicted from his rental home the day prior. [REDACTED] walked to Deputy Adamczyk and was placed into handcuffs without further issue. [REDACTED] stated he was not suicidal and did not have a gun. [REDACTED] was placed in the back of Deputy Adamczyk's patrol vehicle.

Deputy Adamczyk was then able to speak with [REDACTED]. [REDACTED] stated she and [REDACTED] had been arguing all morning. [REDACTED] had told her, he was depressed. [REDACTED] stated they were now living out of their vehicle in a tent due to being evicted. [REDACTED] said [REDACTED] had been driving northbound on John Anderson Dr when he had suddenly stopped and exited the driver's seat. [REDACTED] grabbed a rifle purchased years earlier and walked off into the woods between John Anderson Dr and Ocean Shore Blvd. [REDACTED] stated this occurred at approximately 1140 hours. She then heard "several" gun shots. [REDACTED] drove off and then returned to the area. When she came back, [REDACTED] was sitting on the side of the road with the rifle. [REDACTED] then stood up and began walking towards the Halifax River still holding the rifle. [REDACTED] walked across a small salt marsh and into the mangroves. [REDACTED] stated while [REDACTED] was in the mangroves, she heard a single gun shot. [REDACTED] arrived at the location in an attempt to speak with [REDACTED]. [REDACTED] walked out to where [REDACTED] was located. [REDACTED] stated that was when Deputy Adamczyk drove up.

Deputy Adamczyk then spoke with [REDACTED]. [REDACTED] stated [REDACTED] had called him to talk with [REDACTED] but had not mentioned a firearm. [REDACTED] had no additional details.

Deputies went to the area where [REDACTED] stated [REDACTED] had been standing prior to returning towards the roadway and speaking with Deputy Adamczyk. A rifle was located laying on the vegetation. There was one round left in the magazine. The rifle was secured in order to be submitted under a Risk Protection Order. [REDACTED] confirmed the rifle located was [REDACTED] rifle. [REDACTED] stated [REDACTED] had no additional ammunition or firearms.

When Deputy Adamczyk spoke with [REDACTED] again, [REDACTED] admitted taking the rifle from the vehicle and walking into the woods. [REDACTED] denied making any suicidal statements.

Based upon [REDACTED] and [REDACTED] statements and the locating of the rifle as [REDACTED] described, [REDACTED] was placed under a Baker Act and transported to Halifax Hospital.

During the transport to Halifax Hospital, [REDACTED] stated he had fired several rounds while in the woods between John Anderson Dr and Ocean Shore Blvd and the [REDACTED] knows he target shoots to relieve stress. No casing could be located in the mangrove vegetation and it is not known the exact area [REDACTED] was at while in the woods between John Anderson Dr and Ocean Shore Blvd.
