Narrative

\*\*\* BWC RECORDING\*\*\*

On December 31, 2021, at approximately 2241, Deputy Rogers was dispatched to [REDACTED] Debary, in reference to a suicidal person. Prior to deputies arrival VSO Central Dispatch advised the following: The reporting party [REDACTED] (R1) stated her girlfriend [REDACTED] (V1) made suicidal statements. Deputy Rogers made contact with [REDACTED] via telephone who advised she was driving back to Palm Bay where she lived and [REDACTED] stated she "did not want to do this anymore". [REDACTED] stated [REDACTED] advised she wanted to kill herself but did not mention how she would take her life. [REDACTED] later advised [REDACTED] would not harm herself using her firearms. While speaking with [REDACTED] she did not believe any firearms were in the home due to [REDACTED] recently returning from a two year military deployment.

Upon arrival, Deputies requested Central Dispatch make contact with [REDACTED] via telephone. Deputies made contact with [REDACTED] who did not have any weapons on her person, but appeared to be highly intoxicated. [REDACTED] stated she and her current girlfriend ([REDACTED]) got into a heated argument earlier in the night. [REDACTED] told deputies she did not want to harm or kill herself. Deputy Rogers observed multiple lacerations on [REDACTED] left arm. [REDACTED] initially stated she received the scratches from throwing and breaking multiple items inside her home. While continuing to question [REDACTED] she advised she was unsure of what inside the home actually scratched her arm. [REDACTED] stated she was on multiple medications and believed the medications made her act out of character. [REDACTED] denied medical treatment for her injuries.

[REDACTED] provided verbal consent for deputies to go inside her residence. While inside Deputy Rogers observed multiple items broken and scattered throughout the common living areas. Deputies also observed a black handgun (Glock) located on the floor near the kitchen area by the front door. Next to the firearm was one single unsent 9mm round and multiple pieces of broken items throughout the house. Small droplets of dried blood were also observed near the aforementioned firearm.

[REDACTED] roommate [REDACTED] (O1) arrived at the residence and made contact with deputies. [REDACTED] requested her firearms be turned over to [REDACTED] for safe keeping. [REDACTED] gave deputies verbal consent to document all firearms and ammunition in the residence as well as her vehicle.

[REDACTED] advised there were approximately two firearms in the residence and one located in [REDACTED] vehicle. Deputies observed the following items inside the residence:

- Black Glock 19 Gen 4 Pistol (Serial #RXW260)
- Anderson MFG AM-15 Rifle (Serial #14056984)
- 1 40 Caliber round
- 60 Remington .223 Rounds
- 38 9mm rounds




