██████████ Orange City in reference to a report of a suicidal person complaint. Central dispatch advised the  
suicidal person in question, ██████████ (V1), left the aforementioned residence in a Silver  
Mitsubishi Lancer bearing FL tag (██████████). Deputies observed the vehicle at the intersection of E  
Gardenia Av/S Volusia Av, OC. A traffic stop on the said vehicle was complete and contact was made  
with ██████████ Deputy Galarza responded to the above address and made contact with ██████████ (R1),  
who said the following: At approximately 0200 hours this morning, ██████████ arrived at the residence  
intoxicated. ██████████ woke up and began to pace back and forth stating "I cant do this anymore, please get  
me a gun", and "I want to die". ██████████ stated ██████████ has been suffering with depression for years and also  
said he does not own any weapons. ██████████ did not disclose any new information in reference to the above  
statements said. Base on the above information, ██████████ was placed in protective custody under the Baker  
Act statute. ██████████ was later transported to Stewart Marchman Act located in Daytona Beach for treatment  
without any further incident. An RPO was completed. Case Status: Closed
