BWC RECORDING

On 04-25-2021 at approximately 1742 hours, Deputy Jones responded to ██████████ in reference to a suicidal subject. Upon arrival, deputies made contact with ██████████ (R1) who advised her husband, ██████████ (V1), had made suicidal statements on 04-24-2021. ██████████ stated ██████████ became upset and told her he was going to kill himself if she did not have sex with him. ██████████ further advised ██████████ put a pistol in his mouth and threatened to shoot himself. ██████████ completed a written statement and stated ██████████ also suffered from depression.

Deputy Jones made contact with ██████████ who advised he never made any suicidal statements and that he and ██████████ only had a argument over her infidelity issues.

██████████ was placed under a law enforcement baker act and transported to Stewart Marchman Center.

██████████ advised he did have a pistol and ammo in a safe in the residence. ██████████ wilfully surrendered the firearm and ammo to Deputy Jones and a Risk Protection Order was completed.

Deputy Jones collected 52 9mm rounds of ammunition and a Sig Saur P365 9mm pistol. All items were placed into evidence for safekeeping.

It should be noted there were two children in the residence, ██████████ (O1) and ██████████ (O2), however neither one of them were involved nor saw the incident.

A copy of this report was forwarded to DCF.
