Deputy Blackwell made contact with _____ who appeared intoxicated due to the strong odor of alcohol and her slurring her words. Deputy Blackwell observed a laceration on _____'s right ear. _____ could not provide a valid explanation to her injury and denied all medical treatment. _____ could not advise Deputy Blackwell of today's date, who the president was, or how many quarters there were in a dollar.

After speaking with _____ and _____ Deputy Blackwell determined without further evaluation or treatment _____ posed a significant danger to herself and/or others.

_____ was placed under the protective custody of a Baker Act and later transported to 704 Halifax (303 North Clyde Morris Boulevard, Daytona Beach) by Deputy Becker.
