The following specific statements, actions, or facts give rise to a reasonable fear of significant dangerous acts by the respondent:

Upon arrival Deputy Oldham made contact with [REDACTED] (V1) who stated him and his girlfriend of 6 years, [REDACTED] (V2) got into an argument over money issues. When asked if anything physical took place [REDACTED] stated he was heatin

ing up a bottle for their daughter in common, _____ (O1) when _____ proceeded to attempt to grab the bottle when _____ pushed her hand away. _____ stated he had bought boxes for _____ to move her belongings and that she was free to leave. Deputy Oldham made contact with _____ who stated _____ heard her get up to get a bottle with baby formula and raced to get the bottle first and put it in the microwave.

_____ went on to state she attempted to retrieve the bottle before the temperature was too high when _____ pushed/swatted _____'s hand away from the microwave door twice. _____ proceeded to state she was on a Facetime phone call with her sister at the time of the incident. _____ explained she attempted to leave when _____ made statements regarding shooting himself in the head, which was captured on video and later submitted into evidence to the Digital Crime Scene Database. It shall be noted _____ stated he had been drinking, Deputy Oldham also observed several beer cans where _____ stated he was sitting.

Deputy Oldham inquired of any weapons in the residence for which _____ stated he had 3 rifles and 3 handguns along with several rounds of ammunition. After viewing the video evidence of _____ statements, Deputy Oldham determined without psychological evaluation and treatment _____ posed a significant danger to himself and others. _____ was placed under the protective custody of a Baker Act and later transported to Stewart Marchman without further incident. After completing his investigation, Deputy Oldham determined _____ was the primary aggressor and that he actually and intentionally struck his girlfriend, _____ against her will. Due to the aforementioned, _____ was charged with simple battery touch strike. A pass-along affidavit was turned over to the following shift to carry out when _____ is released. _____ voluntarily surrendered the weapons in the residence and was given a copy of the Risk Protection Order firearm and ammunition receipt. A Risk Protection Order was completed and submitted for _____ completed a sworn written statement regarding the incident.
