On 01/28/2022 at approximately 0032 hours, deputies responded to [REDACTED], Daytona Beach, in reference to a suicidal person. The 911 call advised a heavily intoxicated male at the residence said he was going to kill himself, grabbed two guns, and was being detained by other residents at the home.

Upon arrival, deputies made contact with [REDACTED] (V1) who was sitting outside on the ground. [REDACTED] (V1) family members were outside telling him to stay seated on the ground. Deputies restrained [REDACTED] (V1) who began to actively resist by tensing his body. After being placed in restraints, [REDACTED] (V1) began flailing his body and was assisted into a prone position. [REDACTED] (V1) attempted to kick deputies multiple times and was placed in a hobble restraint. [REDACTED] (V1) shouted profanities at his family members and deputies. [REDACTED] (V1) agreed to walk to the patrol vehicle if the hobble restraint was removed. [REDACTED] (V1) walked towards the patrol vehicle; however, once closer to the vehicle he attempted to pulled away from deputies and lifted his legs off the ground. Three deputies assisted [REDACTED] (V1) headfirst into the patrol vehicle while two deputies were on the opposite side of the vehicle pulling him into the vehicle.

Deputies spoke with [REDACTED] (W1) who advised [REDACTED] (V1) has been having ongoing relationship problems with his girlfriend, "[REDACTED]." [REDACTED] (W1) advised [REDACTED] (V1) had been in an argument with his girlfriend while at a local bar. [REDACTED] (W1) stated [REDACTED] (V1) was dropped off at the residence by his girlfriend around 2300 hours. [REDACTED] (W1) advised [REDACTED] (V1) fell on the floor of his bedroom and began yelling "help me." [REDACTED] (W1) advised he assisted [REDACTED] (V1) onto the bed and while doing so, [REDACTED] (V1) began crying and saying, "I'm a worthless." [REDACTED] (W1) advised [REDACTED] (V1) began to yell loudly at him and [REDACTED] (V1) attempted to open a drawer known to have firearms in it while saying he was going to shoot himself. [REDACTED] (W1) advised he had to physically restrain [REDACTED] (V1) to keep him from grabbing the firearms. [REDACTED] (W1) advised [REDACTED] (V1) regularly drinks alcohol and uses narcotics. [REDACTED] (W1) stated the behaviors displayed by [REDACTED] (V1) during this incident were out of character for him.

Deputies spoke with [REDACTED] (W2) and [REDACTED] (W3) whose accounts of the incident were consistent with [REDACTED] (W1). [REDACTED] advised [REDACTED] (V1) continuously made statements about signing over all his belongings to [REDACTED] (W1) and he was going to dig himself a hole and kill himself. [REDACTED] and [REDACTED] (W1) completed VSO written statements.

Due to the above statements and circumstances, [REDACTED] (V1) was placed under a Baker Act and transported to Halifax Health for a mental health evaluation.


